TERMS AND CONDITIONS:

1. The client agrees to provide **safe** and **appropriate** working conditions, including an area of no less than 6-foot by 6-foot for equipment set-up and adequate electrical power source with 2 outlets on separate circuits within 6-10 feet of the artist's designated setup location. (Set-up and break-down times are **NOT** charged to the client)
2. The DJ/Artist (representative of **MadDawgsEnt**) hereby agrees to provide musical entertainment by means of a recorded musical format suitable for the event designated above . * Unless otherwise specified
3. If the setup location is outside, the client agrees to provide adequate shelter to protect the equipment and DJ/Artist from adverse or harmful weather conditions.
4. The DJ/Artist will be allowed to the easiest and/or closest safe access point to the event location at least 2 hours prior to the event for setup and 60-90 minutes for tear down. The minimum area size needed is **__10__x__10__** for the equipment setup.
*Unless otherwise specified and agreed upon.
5. The client agrees to pay a 1/3 **non-refundable deposit** to reserve the event date. Online and phone reservations are held for only **10 days** to allow time to receive the deposit and contract. **Failure to present your deposit and signed contract within 10 days of verbal or written confirmed hire may result in cancellation. (x)**
6. The remaining balance can be paid at any time before the event date, but is **DUE** in full on the confirmed event date prior to the requested start time. **(x)**
7. Acceptable methods of payment are **CASH, CHECK, MONEY ORDER, CREDIT CARDS, PAYPAL (ELECTRONIC PAYMENT)**. Note: Transaction fees will be added to all credit card/electronic payments in the amount that is charged to **MadDawgsEnt**.
8. **Client(s) is liable for returned checks in the full original amount**, in addition to any late charges assessed by the bank or the amount imposed for each returned check/non-sufficient fund fees.
9. Client(s) shall be held liable for any injury or damages, be it deliberate or due to negligence, to the DJ/Artist(s), representative of **MadDawgsEnt**, or property of said representatives , while on the premises of event. Agreement of liability pertains to any and all damage caused by: Client, guest , employees, or any other party in attendance whether hired, invited or not.
10. **MadDawgsEnt** or any representative thereof will not be held liable for any damage or harm, to property or persons, unless such is caused by gross or wanton negligence on part of a representative of **MadDawgsEnt**. Alleged damage will be presented, acknowledged and itemized before departure of representative of **MadDawgsEnt**. Any acknowledged alleged damage, be it verbally or written, is not admittance to total or

partial responsibility, liability, or monetary obligation of **MadDawgsEnt** or
aforementioned representative (s).

10. The DJ/Artist(s) is not guaranteed nor contractually obligated to perform after contracted time. Additional hours may be purchased only if the DJ/Artist is available, willing, and within the parameters of company policy in the amount agreed upon of no less **\$ 75.00 per hour**.
11. This contract is subject to cancellation only by proven detention by sickness, accidents, death, riots, strikes, epidemics, acts of God, bad weather, power outage, or any other legitimate conditions beyond or representative's reasonable control.
12. This contract is subject to rescheduling only by proven and reasonable cause(s) such as acts of God, bad weather, and power outages. No additional fees will be charged if another available date is chosen. You must notify MadDawgsEnt within **15 days** of your event date if you decide to cancel.
13. In the unlikely event that the designated DJ/Artist is unable to perform at the event, and a replacement cannot be found, Maddawgs Entertainment will make a full refund of any deposits or payments made by the Client(s). The Client agrees that the refund will be in the amount of confirmed and provable prior payment and no further damages may be sought against Maddawgs Entertainment or any of its representatives.
14. If for any reason, that MadDawgsEnt or Representative is not directly at fault or proven culpable, the event concludes in less than the contracted # of hours, the Client is still required to make full payment and there will be **NO REFUNDS**.
15. The Client(s) agrees to not change the event location without informing Maddawgs Entertainment at least 24 hours prior to the event date/time. Added fees may apply.
16. Maddawgs Entertainment/ Representatives reserves the right and discretion to stop, delay, or end performance/service and to adhere safety measures or precautions if dangerous or illegal conditions arise to ensure the safety of DJ/Artists/representative and equipment.
18. ***Maddawgs Entertainment reserves the right to print, publish, and use any image, likeness or sound generated during the course of the event as promotional items for brochures, photo album displays, website displays, as well as social media promotions. _____ Initial here for the purpose to prove you have read and accept line item #18.***
19. If litigation for violation of any item in this contract agreement is necessary, Maddawgs Entertainment shall be entitled to all reasonable attorney fees, court costs, and collection expenses including punitive damages/loss of wages.
20. **Full amount of deposit is due and payable at time of signing.**
